

# Pilgrimage to TTALY and the SHROUD of TURIN

### Day 1 - June 15: Depart U.S.A.

Our pilgrimage begins as we depart on our overnight flight to Rome. Meals and refreshments will be served aloft.

### **Day 2 - June 16: Arrive Milan / Turin**

Upon arrival in Milan we will be met by our local guide who will be with us throughout our stay in Italy. Upon arrival in Milan enjoy a city tour including visits to the Duomo, La Scala Opera House (outside visit), and the Church of Santa Maria delle Grazie which houses the "Last Supper" painting by Leonardo da Vinci (strictly subject to availability). Then depart Milan and drive to Turin for overnight.



### **Day 3 - June 17: Turin / Florence**

Today we will view the Shroud of Turin in the Cathedral of St. John the Baptist. The Shroud is said to be the burial cloth of Christ and it bears the distinct image of a crucified man. We will have what is perhaps an once-in-a-lifetime opportunity to view the Shroud. After viewing the Shroud we will enjoy a tour of the city including visits to the Palazzo Real, Palazzo Madama, and Mole Antonelliana. We will then depart Turin and drive to Florence, the "cradle of the Italian Renaissance".



### **Day 4 - June 18: Florence**

Our tour of Florence this morning is an artful
experience as we take in the Ponte Vecchio, the

Duomo, the Baptistery with its renowned bronze doors, the replica of the famous statue of David by Michelangelo outside the Palazzo Vecchio, Santa Maria Novella Church and Santa Croce

Church. The remainder of the afternoon is free

for personal activities.

### Day 5 - June 19: Florence / Siena / Assisi

In the morning we will depart Florence and drive south to Siena, home of St. Catherine. Our first stop this morning and a highlight of our tour will be the Basilica of St. Francis where we'll venerate the



Eucharistic miracle of Siena. Then we'll celebrate Mass at St. Dominic's, St. Catherine of Siena's parish church where she attended daily Mass and went into ecstasy. Adjacent to the church is her home, which we'll tour and see the cell where she fasted and prayed. Then we'll stroll the ancient Gothic streets which converge on the Piazza del Campo, one of the most beautiful squares in the world where we can stop for lunch. Continue our drive south to Assisi, the home of St. Francis and St. Clare.

### Day 6 - June 20: Assisi

This morning we will visit St. Mary of the Angels Basilica, site of the Porziuncola, the tiny church in the woods where St. Francis began his ministry and where St. Clare began her religious life. Then • proceed to the Basilica of St. Francis where the saint lies in rest where we will celebrate Mass. Then visit the Basilica of St. Clare and the Convent of San Damiano. For those with the stamina, take a walk up Monte Subasio to Eremo delle Corceri, the Saint's favorite retreat. Overnight in Assisi.

### **Day 7 - June 21: Assisi / Orvieto / Rome**

pilgrimage, attendance at the Papal Audience at St. Peter's (subject to the Holy Father's schedule). Join thousands of pilgrims from throughout the world to listen to the Holy Father and receive His Blessing. In the afternoon our sightseeing includes visits to St. Mary Major Basilica, St. John Lateran, and the Holy Stairs. This evening enjoy a farewell dinner at a local restaurant.

### Day 11 - June 25: Depart Rome

Following breakfast, transfer to the airport for our return flight home.







This morning we will depart Assisi and drive south to Orvieto, home to Italy's most stunning Gothic Cathedral, where the Feast of Corpus Christi began. After a brief visit we will continue on to Rome for overnight.

### **➢** Day 8 - June 22: Rome

A full day of exploring Rome begins with Mass • at St. Peter's Basilica. Our guide then takes us through the Vatican Museum and the Sistine Chapel with its awesome frescoes painted by Michelangelo. In the afternoon we will continue our exploration of Rome with a visit to the Renaissance section of the city. See the Trevi Fountain where a coin thrown over your shoulder will guarantee you another visit to Rome; the Pantheon; Piazza Navona with Bernini's famous fountains; and Campo de' Fiori which is one of the most colorful street markets in Rome.

### Day 9 - June 23: Rome

Today we will enjoy a full day sightseeing tour of Rome including visits to the Roman Forum, the Colosseum, St. Peter in Chains featuring • Michelangelo's "Moses", and St. Paul Outside • the Walls where Mass will be celebrated. Then proceed to the San Callisto Catacombs for a visit before returning to our hotel.

### **Day 10 - June 24: Rome**

This morning we will experience a highlight of our

**Reservations and Payment:** Tekton Ministries requires a deposit of \$300.00 per person at the time of booking. This deposit forms a part of your final payment which is due 75 days prior to departure. Reservations made within 74 days of departure must be accompanied by payment in full. Payments made by credit card will incur a convenience fee. Any reservations received within 45 days of departure will incur a late booking fee of \$100.00 per person. This pilgrimage is based upon a minimum of 22 total pilgrims. Surcharges may be assessed for a smaller group size.

Cancellations: All cancellations must be in writing. The following per person cancellation charges will apply in addition to any charges incurred by our suppliers: If canceled 91 days or more prior to departure, a \$50.00 administrative fee will be charged. If canceled 90 - 31 days prior to departure, \$150.00 will be charged. If canceled 30 - 15 days prior to departure, \$450.00 will be charged. If canceled 14 - 7 days prior to departure \$700.00 will be charged. No refunds will be made within 6 days of departure. In addition, once the airline tickets have been issued, 100% of the airfare is non-refundable unless you have been advised otherwise at the time of your booking.

**Travel Documents:** A passport which is valid for 6 months past the date of your return flight home is required of all U. S. citizens. However, U.S. citizens do not require visas for Italy. If you are not a U.S. citizen, please call to find out if you need a visa. Tekton Ministries is not responsible for individual visas or passports.

**Hotels:** Accommodations are based on double occupancy rooms with private facilities. A limited number of single rooms are available at the supplement quoted and should be requested at the time of booking.

**Air Transportation:** Air travel is in economy class on Delta Airlines. Fares are based upon levels in effect at the time of printing and fares and flight schedules are subject to change without notice.

**Baggage:** Each passenger is allowed one checked bag and one carryon. Tekton Ministries is not responsible for lost, damaged or stolen baggage.

**Travel Insurance:** We strongly recommend that you purchase comprehensive travel insurance for your trip. Registration information will be provided upon receipt of your deposit.

**Not Included:** Airline taxes/fuel surcharges (currently \$627.87 per person subject to change until the time of ticketing), passport/visa fees, personal travel insurance, laundry, beverages and items not on the regular menu of included meals, excess baggage charges, optional sightseeing and expenses of a personal nature.

**Refunds:** Subject to the foregoing Cancellation Terms, upon cancellation of travel related services, all sums paid to Tekton Ministries/George's International Tours for such services will be promptly returned to the passenger, <u>provided</u> the passenger has not caused such cancellation and is not in violation of any of the terms and conditions previously, clearly and conspicuously disclosed and agreed to by the passenger.  Trust Account Disclosure: California law requires certain sellers of travel to have a trust account or bond. George's International Tours has such a trust account.

Travel Consumer Restitution Corporation ("TCRC"): George's International Tours is a participant in the Travel Consumer Restitution Corporation ("TCRC"). You, the passenger, may request reimbursement from TCRC if George's International Tours was registered and participant in the TCRC at the time of sale and the passenger is located in California at the time of payment. Please be advised that passengers purchasing from outside of California are not covered by the TCRC. Eligible passengers may file a claim with TCRC if the passenger is owed a refund of more than \$50 for transportation or travel services which George's International Tours failed to forward to a proper provider or if such money was not refunded to you when required. The maximum amount, which may be paid by the TCRC to any one passenger is the total amount paid on behalf of the passenger to George's International Tours, not to exceed \$15,000. A claim must be submitted to the TCRC within six months after the scheduled completion date of the travel. A claim must include sufficient information and documentation to prove your claim and a \$35 processing fee. You must agree to waive your right to other civil remedies against a registered participating Seller of Travel for matters arising out of a sale for which you file a claim with the TCRC, if you were located in California at the time of the sale.
