Pílgrímage to ITALY



May 9th - 20th, 2016

> Pilgrimage Itinerary



Day 1 - May 9: Depart USA

Our pilgrimage begins as we depart on our overnight flight to Venice. Meals and refreshments will be served aloft.

➢ Day 2 - May 10: Arrive Venice

Upon arrival in Venice, Italy's most colorful city, we will be met by our local tour director and transfer to our hotel.

➢ Day 3 - May 11: Venice

This morning we'll enjoy a walking tour of Venice, first visiting St. Mark's Square (Piazza San Marco) and St. Mark's Basilica (Basilica di San Marco) which was built to house the remains of St. Mark. Also visit the famous Doges' Palace and "Bridge of Sighs." The balance of the day is free to explore this fascinating city of islands on our own.



Day 4 - May 12: Venice / Padua / Siena

We will depart Venice this morning and drive south to Padua visit the Basilica of St. Anthony, the Duomo and Baptistery, and the Capella degli Scrovegni with its beautiful frescoes painted by Giotto. Then continue south to Siena, the home of St. Catherine for overnight.

Day 5 - May 13: Siena / Assisi

Our first stop this morning and a highlight of our tour will be the Basilica of St. Francis where we'll venerate the Eucharistic miracle of Siena. Then we'll celebrate Mass at St. Dominic's, St. Catherine of Siena's parish church where she attended daily Mass and went into ecstasy. Adjacent to the church is her home, which we'll tour and see the cell where she fasted and prayed. Then we'll stroll the ancient Gothic streets



which converge on the Piazza del Campo, one of the most beautiful squares in the world where we can stop for lunch. We will then drive south to Assisi, a town which welcomes us in the spirit of St. Francis and St. Clare into its peaceful interior.

Day 6 - May 14: Assisi

This morning we will visit St. Mary of the Angels Basilica, site of the Porziuncola, the tiny church in the woods where St. Francis began his ministry and where St. Clare began her religious life. Then enjoy a sightseeing tour of Assisi including visits to the Convent of San Damiano where the miracle of the Eucharist of 1211 took place, the Basilica of St. Francis, the Basilica of St. Clare, and Santa Maria degli Angeli. Continue on to the Rocca Maggiore, a castle which dominates the entire skyline with its impressive battlements. Then for those with the stamina, take a walk up Monte Subasio to L'Eremo delle Carceri (the



Carceri Hermitage), the Saint's favorite retreat. There are many caves here that St. Francis and his followers retreated to for seclusion and prayer. Overnight in Assisi.

Day 7 - May 15: Assisi / Loreto / Lanciano / San Giovanni Rotondo

This morning we will depart Assisi and drive south to Loreto where we will see the Shrine of the Holy House which is said to be the same house in which the Virgin Mary was born and raised in Nazareth.
This is where she received the visitation of the angel announcing that she was the mother of Jesus and according to tradition the home was transported by four angels from Nazareth to its present resting place in Loreto. We will then proceed to Lanciano, site of the 8th century Miracle of the Eucharist, where bread

and wind became real flesh and blood. After Mass in Lanciano we will proceed to San Giovanni Rotondo, the birthplace and home of St. Padre Pio.

Day 8 - May 16: San Giovanni Rotondo /

Manoppello / Rome

This morning we will enjoy a tour of this quaint 11th century town where the famous Padre Pio spent most of his life. Visit the Capuchin Monastery where Padre Pio lived, the Church of Santa Maria delle Grazie, and the Padre Pio Pilgrimage Church which was completed in 2004 and Padre Pio's Tomb. Next drive up to Monte Sant' Angelo for a breathtaking view of the Gargano Peninsula and a visit to the Grotto of Michael the Archangel. In the afternoon we will depart San Giovanni Rotondo and drive to Manoppello where we will visit the Basilica of Volto

Peter in Chains featuring Michelangelo's "Moses" and St. Paul Outside the Walls which was originally built by Constantine in the fourth century over the

site of St. Paul's tomb where Mass will be celebrated.

After lunch we will continue our exploration of Rome with a visit to the Renaissance section of the city. We will see the Trevi Fountain where a coin thrown over

your shoulder will guarantee you another visit to Rome, the Pantheon, Piazza Navona with Bernini's famous fountains and Campo de' Fiori which is one


of the most colorful street markets in Rome. This evening we will enjoy a farewell dinner at a local

restaurant.

Day 12 - May 20: Rome / U.S.A.

Following breakfast, transfer to the airport to catch our return flight home.







Santo which contains an image on a thin veil which is known as the Holy Face of Manoppello and has been reputed to be the veil that covered Christ's face during His burial and resurrection. After a brief visit of Manoppello we will continue on to the "Eternal City" of Rome.

➢ Day 9 - May 17: Rome

We'll begin our day in Rome with Mass in St. Peter's Basilica, followed by a tour including the Pieta and Adoration Chapel which St. John Paul II opened in 1981. Then take a tour of the Vatican Gardens and visit the Scavi excavations underneath St. Peter's (not included in the price and subject to availability). We will then explore the Vatican Museum and the Sistine Chapel with its awesome frescoes painted by Michelangelo focusing especially on Eucharistic art and artifacts.

Day 10 - May 18: Rome

This morning we will experience a highlight of our pilgrimage, attendance at the Papal Audience at St. Peter's (subject to the Holy Father's schedule). Join thousands of pilgrims from throughout the world to listen to the Holy Father and receive his blessing. In the afternoon our sightseeing includes visits to St. Mary Major Basilica, St. John Lateran, the Holy Stairs, the Old Appian Way and the St. Sebastian Catacombs.

➢ Day 11 - May 19: Rome

This morning we'll head to the Mamertine Prison where St. Paul was kept in chains, view the Forum (outside visit) and Coliseum (outside visit) and stop at St. Clement's, to see the second century dwelling of Pope St. Clement, the third successor of St. Peter, and the original fresco depicting St. Clement celebrating the Holy Sacrifice of the Mass. This fresco gives us a picture of Eucharistic worship at the end of the first century or beginning of the second. Proceed to St.

Reservations and Payment: Tekton Ministries requires a deposit of \$300.00 per person at the time of booking. This deposit forms a part of your final payment which is due 75 days prior to departure. Reservations made within 74 days of departure must be accompanied by payment in full. Payments made by credit card will incur a convenience fee. Any reservations received within 45 days of departure will incur a late booking fee of \$100.00 per person. This pilgrimage is based upon a minimum of 22 total pilgrims. Surcharges may be assessed for a smaller group size.

Cancellations: All cancellations must be in writing. The following per person cancellation charges will apply in addition to any charges incurred by our suppliers: If canceled 91 days or more prior to departure, a \$50.00 administrative fee will be charged. If canceled 90 - 31 days prior to departure, \$150.00 will be charged. If canceled 30 - 15 days prior to departure, \$450.00 will be charged. If canceled 14 - 7 days prior to departure \$700.00 will be charged. No refunds will be made within 6 days of departure. In addition, once the airline tickets have been issued, 100% of the airfare is non-refundable unless you have been advised otherwise at the time of your booking.

Travel Documents: A passport which is valid for 6 months past the date of your return flight home is required of all U. S. citizens. However, U.S. citizens do not require visas for Italy. If you are not a U.S. citizen, please call to find out if you need a visa. Tekton Ministries is not responsible for individual visas or passports.

Hotels: Accommodations are based on double occupancy rooms with private facilities. A limited number of single rooms are available at the supplement quoted and should be requested at the time of booking.

Air Transportation: Air travel is in economy class on Delta Airlines/KLM. Fares are based upon levels in effect at the time of printing and fares and flight schedules are subject to change without notice.

Baggage: Each passenger is allowed one checked bag and one carryon. Tekton Ministries is not responsible for lost, damaged or stolen baggage.

Travel Insurance: We strongly recommend that you purchase comprehensive travel insurance for your trip. Registration information will be provided upon receipt of your deposit.

Not Included: Passport/visa fees, Airline taxes/fuel surcharges (currently \$669.01 but subject to change until the time of ticketing), gratuities, personal travel insurance, laundry, beverages and items not on the regular menu of included meals, excess baggage charges, optional sightseeing and expenses of a personal nature.

Refunds: Subject to the foregoing Cancellation Terms, upon cancellation of travel related services, all sums paid to Tekton Ministries/George's International Tours for such services will be promptly returned to the passenger, <u>provided</u> the passenger has not caused such cancellation and is not in violation of any of the terms and conditions previously, clearly and conspicuously disclosed and agreed to by the passenger. This refund provision does not apply where Tekton Ministries/George's International Tours has remitted the payment to another registered seller of travel or a carrier and they default in providing the agreed-upon transportation or service without providing a refund. In such a situation, Tekton Ministries/George's International Tours agrees to provide passenger with a written statement accompanied by a copy of the bank records

establishing the disbursement of the payment, and if disbursed to a seller of travel, proof of their current registration.

 Trust Account Disclosure: California law requires certain sellers of travel to have a trust account or bond. George's International Tours has such a trust account.

Travel Consumer Restitution Corporation ("TCRC"): George's International Tours is a participant in the Travel Consumer Restitution Corporation ("TCRC"). You, the passenger, may request reimbursement from TCRC if George's International Tours was registered and participating in the TCRC at the time of sale and the passenger is located in California at the time of payment. Please be advised that passengers purchasing from outside of California are not covered by the TCRC. Eligible passengers may file a claim with TCRC if the passenger is owed a refund of more than \$50 for transportation or travel services which George's International Tours failed to forward to a proper provider or if such money was not refunded to you when required. The maximum amount, which may be paid by the TCRC to any one passenger is the total amount paid on behalf of the passenger to George's International Tours, not to exceed \$15,000. A claim must be submitted to the TCRC within six months after the scheduled completion date of the travel. A claim must include sufficient information and documentation to prove your claim and a \$35 processing fee. You must agree to waive your right to other civil remedies against a registered participating Seller of Travel for matters arising out of a sale for which you file a claim with the TCRC, if you were located in California at the time of the sale.
