## *Pilgrimage to* **Santiago de Compostela** *and the 100th Anniversary of* **Fatima**



October 3<sup>rd</sup> - 14<sup>th</sup>, 2017

## PILGRIMAGE ITINERARY

### ✠ Day 1 - Oct. 3rd: Depart U.S.A.

Today you will depart on your overnight flight to Madrid, Spain.

### ✠ Day 2 - Oct. 4th: Arrive Madrid / Avila / Salamanca

After our morning arrival in Madrid we will be met by our tour manager who will be with us on our entire pilgrimage. Continue to the walled city of Avila, the birthplace of St. Teresa. Visit the Convent of St. Teresa which was built after the canonization of St. Teresa (1515-82) over the house where she was born. Visit the Monastery of the Incarnation where St. Teresa spent many years of her life, then to the Monastery of St. Joseph, her first foundation. Depart Avila and drive to Salamanca for overnight.

### ✠ Day 3 - Oct. 5th: Salamanca / Sarria

Salamanca is one of Spain's foremost cultural centers, a great university city and a showcase of intricately sculpted Renaissance architecture in golden stone. Visit the Plaza Mayor, which is regarded as one of the most attractive squares in Spain, and the Cathedrals Vieja and Nueva. We will then drive to Alba de Tormes to visit the Carmelite Convent which contains St. Teresa's incorrupt arm and heart. Then continue west to Sarria, which is a popular pilgrims' starting point for the Camino de Santiago. Overnight in Sarria.

### ✠ Day 4 - Oct. 6th: Sarria / Portomarin (14 mi)

Today we will begin our walk along the Camino de Santiago. Today's walk is spread equally between quiet country roads and natural pathways, passing through many small hamlets that seem to blend seamlessly one into the next. Overnight in Portomarin.

### ✠ Day 5 - Oct. 7th: Portomarin / Palas de Rei (16 mi)

A day of varied terrain as you start skirting Belesar reservoir and climbing up through woodland before a further gentle climb to Alto do Rosario (Rosary Heights). A short descent takes you to your accommodation in Palas de Rei.



### ✠ Day 6 - Oct. 8th: Palas de Rei / Melide (12 mi)

Today you will cross four river valleys mostly on pathways through woodland. In Melide, a medieval township with close links with the Jacobean pilgrimage, the French Way temporarily becomes an urban route. Visit the town's medieval center and churches, and try Melide's local delicacy: Pulpo (Octopus). Overnight in Melide.

### ✠ Day 7 - Oct. 9th: Melide / Arzua (9 mi)

Today's walk takes you through meadows, oak and eucalyptus woodland through countless small hamlets, some of which bear names that echo their historical connections with the Pilgrim's way. This is the county of Arzua, a land with a strong dairy production and known for its delicious cheeses.

### ✠ Day 8 - Oct. 10th: Arzua / Lavacolla (17 mi)

Walk on natural pathways with good shade offered by trees. The Camino now becomes busier with pilgrims as we near the fabled city of Santiago.

### ✠ Day 9 - Oct. 11th: Lavacolla / Santiago de Compostela (7 mi)

The first part of your final stage into Santiago is through dense woodland. Enjoy the shade and peace - as you approach the city, asphalt roads take over. After leaving the town of Lavacolla, the Way approaches the Monte do Gozo (The Mount of Joy), a small hillock from



which the pilgrim can see, for the first time, in the distance, the towers of the Cathedral of Santiago, hence the name of this spot.



✝ **Day 10 - Oct. 12th: Santiago de Compostela / Penela**

This morning we will enjoy a complete tour of Santiago de Compostela. Visit the impressive Cathedral which is considered to be one of the finest pieces of architecture in Europe. After Mass, climb up the stairs behind the altar to visit the crypt, where a silver urn contains the relics of St. James. See the Portico de la Gloria (Gateway to Heaven), an unparalleled masterpiece. Walk to the top of the Cathedral for a panoramic view of this glorious city. We will also visit the museum in the cloister adjoining the Cathedral. In the afternoon, we will depart Santiago de Compostela and drive south to Penela for overnight.

✝ **Day 11 - Oct. 13th: Penela / Fatima / Penela**

This morning we will drive to Fatima, where the Blessed Virgin appeared to three shepherd children, Lucia, Francisco and Jacinta, in 1917. Take part in the celebrations surrounding the 100th anniversary of the last apparition. Visit the Basilica to see the site of Francisco and Jacinta's graves and then on to the hamlet of Aljustrel where the three children lived during the Apparitions. Continue to Valinhos, the site where Our Lady appeared following the children's release from prison. Return to Penela for overnight.

✝ **Day 12 - Oct. 14th: Penela / Lisbon / U.S.A.** Transfer to the airport in Lisbon to catch our return flight home.

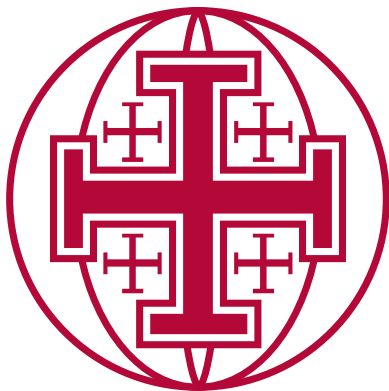

**Reservations and Payment:** Tekton Ministries requires a deposit of \$300.00 per person at the time of booking. This deposit forms a part of your final payment which is due 75 days prior to departure. Reservations made within 74 days of departure must be accompanied by payment in full. Payments made by credit card will incur a convenience fee. Any reservations received within 45 days of departure will incur a late booking fee of \$100.00 per person. This pilgrimage is based upon a minimum of 17 total pilgrims. Surcharges may be assessed for a smaller group size.

**Cancellations:** All cancellations must be in writing. The following per person cancellation charges will apply in addition to any airline penalties and charges incurred by our suppliers: If canceled 91 days or more prior to departure, a \$75.00 administrative fee will be charged. If canceled 90 - 31 days prior to departure, \$150.00 will be charged. If canceled 30 - 15 days prior to departure, \$450.00 will be charged. If canceled 14 - 7 days prior to departure \$700.00 will be charged. No refunds will be made within 6 days of departure. In addition, once the airline tickets have been issued, 100% of the airfare is non-refundable unless you have been advised otherwise at the time of your booking.

**Travel Documents:** A passport which is valid for 6 months past the date of your return flight home is required of all U. S. citizens. However, U.S. citizens do not require visas for Spain or Portugal. If you are not a U.S. citizen, please call to find out if you need a visa. Tekton Ministries is not responsible for individual visas or passports.

**Hotels:** Accommodations are based on double occupancy rooms with private facilities. A limited number of single rooms are available at the supplement quoted and should be requested at the time of booking.

**Air Transportation:** Air travel is in economy class on American Airlines/British Airways. Fares are based upon levels in effect at the time of printing and fares and flight schedules are subject to change without notice.

**Baggage:** Each passenger is allowed one checked bag and one carry-on. Tekton Ministries is not responsible for lost, damaged or stolen baggage.

**Travel Insurance:** We strongly recommend that you purchase comprehensive travel insurance for your trip. Registration information will be provided upon receipt of your deposit.

**Not Included:** Passport/visa fees, airline taxes/fuel surcharges (\$127.86 per person subject to change until the time of ticketing), personal travel insurance, laundry, beverages and items not on the regular menu of included meals, excess baggage charges, optional sightseeing and expenses of a personal nature.

**Refunds:** Subject to the foregoing Cancellation Terms, upon cancellation of travel related services, all sums paid to Tekton Ministries/George's International Tours for such services will be promptly returned to the passenger, provided the passenger has not caused such cancellation and is not in violation of any of the terms and conditions previously, clearly and conspicuously disclosed and agreed to by the passenger. This refund provision does not apply where Tekton Ministries/George's International Tours has remitted the payment to another registered seller of travel or a carrier and

they default in providing the agreed-upon transportation or service without providing a refund. In such a situation, Tekton Ministries/George's International Tours agrees to provide passenger with a written statement accompanied by a copy of the bank records establishing the disbursement of the payment, and if disbursed to a seller of travel, proof of their current registration.

**Trust Account Disclosure:** California law requires certain sellers of travel to have a trust account or bond. George's International Tours has such a trust account.

**Travel Consumer Restitution Corporation ("TCRC"):** George's International Tours is a participant in the Travel Consumer Restitution Corporation ("TCRC"). You, the passenger, may request reimbursement from TCRC if George's International Tours was registered and participating in the TCRC at the time of sale and the passenger is located in California at the time of payment. Please be advised that passengers purchasing from outside of California are not covered by the TCRC. Eligible passengers may file a claim with TCRC if the passenger is owed a refund of more than \$50 for transportation or travel services which George's International Tours failed to forward to a proper provider or if such money was not refunded to you when required. The maximum amount, which may be paid by the TCRC to any one passenger is the total amount paid on behalf of the passenger to George's International Tours, not to exceed \$15,000. A claim must be submitted to the TCRC within six months after the scheduled completion date of the travel. A claim must include sufficient information and documentation to prove your claim and a \$35 processing fee. You must agree to waive your right to other civil remedies against a registered participating Seller of Travel for matters arising out of a sale for which you file a claim with the TCRC, if you were located in California at the time of the sale.
